- 7. To offer, make available and render any of the services and aids essential to industry and business marketing and allied field such as buying, selling, assembling, grading, standardising, packing, processing, advertising, publicity, market survey, research, sales promotion, after sales services, maintenance services, contract services and other allied services.
- 8. To manufacture, assemble, fabricate, process, buy, sell, import, export and deal in plant, machinery, equipments required in connection with the objects of the Company.
- 9. To apply for tender, purchase or otherwise acquire any contracts, sub-contracts, licences and concessions for or in relation to the objects or business herein and to undertake, execute, carry out, dispose of or otherwise turn to account the same.
- 10. To acquire and take over as a going concern by purchase of or on lease and to undertake, to carry on the whole or any part of the business together with the goodwill and trade namee, property rights and liabilities of any person or persons, firm or any company carrying on any business which is within the objects of the Company and to pay for the same by shares, debentures, debenture-stock, bonds, cash or otherwise and to conduct and carry on or liquidate and wind up any such business.

To promote, form and register and aid in promotion, formation and registration of any company or companies subsidiary or otherwise, for the purpose of acquring all or any of the property, undertaking, rights and liabilities of such company and to be interested in, or take or otherwise acquire, purchase, hold, sell or otherwise dispose of shares, debentures and other securities in or of any such company, or any other company, for all or any of the objects mentioned in this Memorandum and to subsidise or otherwise assist any such

company and to undertake the management or other work duties, and business of any such company on such terms and conditions as may be determined.

- 32. To create any depreciation fund, reserve fund, sinking fund, insurance fund, dividend equalising fund, capital redemption fund or any other special fund whether for depreciation, or for repairing, improving, extending or maintaining any of the property of the Company or for redemption of debentures or redeemable preference shares, or for any other purpose whatsoever conducive to the interest of the Company.
- 33.
